About CUHK LAW

Since its establishment in 2006, the Faculty of Law of The Chinese University of Hong Kong (CUHK LAW) has become one of the leading law schools in Asia. CUHK LAW was ranked top 50 in the QS World University Rankings by Subject 2025: Law & Legal Studies. In the 2014 Research Assessment Exercise (RAE) conducted by the University Grants Committee of Hong Kong, CUHK LAW was recognised as Hong Kong's best research law faculty. In the RAE 2020, CUHK LAW was again overall leading in Hong Kong in the law domain with 83% of its research activity being rated as 4* ("world leading") and 3* ("internationally excellent"). CUHK LAW is currently the home of more than 50 academic staff from 20 jurisdictions, with diverse research interests and expertise.

CUHK LAW offers the following academic programmes: Bachelor of Laws (LLB), Juris Doctor (JD), Postgraduate Certificate in Laws (PCLL), Master of Laws (LLM) in Chinese Business Law, LLM in Common Law, LLM in Energy and Environmental Law, LLM in International Economic Law, and LLM in Legal History. Furthermore, two research postgraduate programmes are available at CUHK LAW, i.e. the Master of Philosophy in Laws (MPhil) and the Doctor of Philosophy in Laws (PhD). On top of these, CUHK LAW also operates four double degree programmes: the Dual LLB-JD with University of Exeter, the Dual LLB-JD with the Dickson Poon School of Law of King's College London (KCL), the BBA-JD and the JD-MBA with the CUHK Business School. CUHK LAW currently offers the following law and technology related courses: Chinese Law and Society in an Age of Digital Technologies and Artificial Intelligence; Copyright, Digital Subject Matter & Information Technology; Digital Technology and Law; Introduction to Artificial Intelligence & the Law; The Internet and the Law; The Law of Electronic Commerce; The Law of the Digital Economy; Legal Practice and Technology; Legal Technologies; and Principles of Digital Technology and Law.

CUHK LAW's headquarters are at the University's main campus in Shatin. All taught postgraduate courses are delivered at its Graduate Law Centre located in Hong Kong's central business district in Central. CUHK LAW has established two research centres - the Centre for Comparative and Transnational Law (CCTL) and the Centre for Legal Innovation and Digital Society (CLINDS).
